


AFFIDAVIT OF UNDERTAKING

7. I am executing this Affidavit of Undertaking to attest to the truth of the foregoing and for whatever legal purpose and intent it may serve.

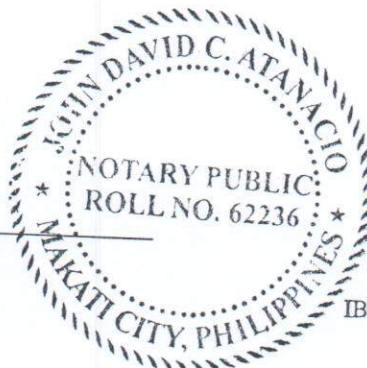

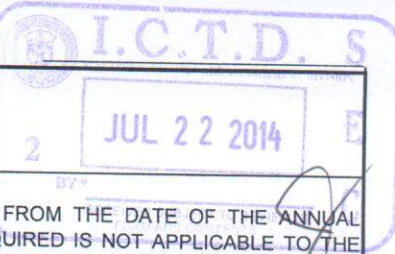

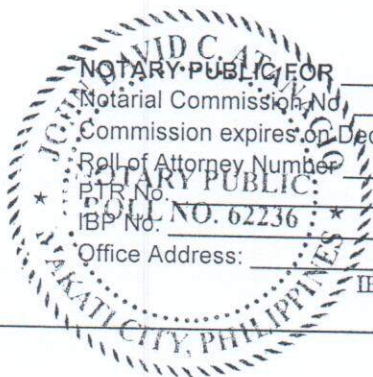
